45th TASART Exhibition 2023

The Burnie Coastal Art Group Inc was formed 72 years ago and in that time they have purchased their own Gallery and Studio at 211- B Mount Street Upper Burnie.

TASART assists with the upkeep of the facilities as well as promoting artists and their work.

The total prize pool for 2023 is \$15,250.00 with 12 awards.

THE WORK.

1. 2D Artists may enter one work only, suitably framed for hanging with "D" rings 1/3 from top of frame and the wire 8 cm from the top. Stretched canvas is acceptable. Works including multi panels are not to exceed 190cm in area. 2D work not to exceed 10k in weight. Work must be accompanied by Section A of entry form on the bottom right hand corner. B form to be sent by email or post.

2. Entry forms can be completed online or posted. Email to Suzanne Hennessy suzart1954@gmail.com. Entries will not be accepted without signed and completed form. An entry fee of \$50.00 to be paid by bank transfer or by post to **TASART BCAG P.O. Box 186 Burnie.** or **211-B Mount Street Upper Burnie 7320.**

3. All artworks must be the original work and concept of the artist and completed in the last twelve months. Work must not have been previously exhibited. Any alleged breach must be reported to the President of BCAG within two weeks of opening. **All paintings must stay in the exhibition until the end of the exhibition.**

4. 2D works must be on canvas, board or paper. Photography, film, wet work, unprotected tempera or copies will not be accepted.

5. By entering and accepting the conditions you allow BCAG to publicise work entered through the printed and social media.

THE EXHIBITION.

1. All works entered into the exhibition will be displayed and open to judging. Works will be for sale with a commission of 25%. BCAG reserves the right to reject any entries. Irrespective of selling price, an artist winning a particular category/section will only be awarded the amount of prize money stated for that section. Awards 1 through to 10 are acquisitive.

2. The BCAG 211-B Mount Street Upper Burnie will exercise all reasonable care in handling the works, but will not be liable for any loss or damage to any art works while in their custody or in transit. Artists are responsible for insuring their own art works.

3. If consigning work via post or carrier, prepaid return freight vouchers must be included with the artwork when received. No payment will be made by BCAG for delivery or return of work. If work is sold prepaid vouchers will be returned.

COLLECTION AND RETURN OF WORKS.

At the close of the exhibition on Saturday 4th November work can be collected from BCAG between 2.45pm and 3.30pm or between 10.am and 1.pm on Sunday 5th November. Works to be returned by post or carriers will be packed and sent on the morning of Monday 6th November. Take note of this date when organizing return freight vouchers. Works not collected by the artist within 6 months of the relevant TASART Exhibition will become the property of the BCAG and may be sold by the group.
